2. <u>Sign Review:</u> 218 Main Street, Keystone Place approval for new sign.

Mr. Fahey: Presented materials

Mr. Shearer: Questions location of the sign.

Mr. O'Connor: From materials submitted it looks as though sign will be placed at the corner

of the parking lot just past the entry of parking area.

Mr. Fahey: Yes.

Mr. Shearer: Placement agreeable, are there any other questions?

Ms. Oliva: Questions lighting.

Mr. Fahey: No lights.

Mr. Shearer: Size is agreeable.

Mr. O'Connor: Made a motion to approve the sign as presented, Ms. Oliva seconds the motion. Motion approved 4-0

3. <u>Project Review:</u> 46 Holt Road, DRC review per section 2815 of Zoning Bylaw. This project consists of constructing 2 duplex residences, 4 units each with 3 bedrooms.

Mr. Ladd: Presents building plans, are there any questions. Windows will be 4 over one, with historic sill. Siding will be clapboard or shingles staying with Cape Cod grey.

Mr. O'Connor: Questioning no access to the back yard from each unit.

Mr. Ladd: These are conceptual plans. It will take away storage space.

Mr. O'Connor: Buyers would most likely appreciate a back access.

Ms. Oliva: The back is not desirable looking to much blank space that can be seen from the road. How many units.

Mr. Ladd: There are 4 units.

Mr. Shearer: We can't tell you how to design your building, we can only make suggestions. **Mr. Ladd:** We do want it aesthetically pleasing. Landscape plans show grass areas and rain gardens.

Mr. O'Connor: A definitive landscape plan needs to be submitted.

A detailed planting list.

• Planting notes for rain gardens with quantities.

- Plans for trees that are likely salvageable and tagged with a snow fence for protection.
- Driveways in road layout.
- Show walkways from front doors on plans.
- Note where a dumpster could potentially be located.

Ms. Azarovitz: We need two documents.

- Plantings & Landscape plan.
- Lighting Illumination plan.

Mr. Shearer: Committee Members decision. **Mr. O'Connor:** Submission not complete.

Mr. Shearer: Continuance, no decision for Planning Board.

Mr. Shearer made a motion for a continuance, no decision for Planning Board. Next meeting to be determined. Ms. Oliva seconded the motion. Motion approved 4-0

4. <u>Enforcement:</u>

Discussions were held regarding 13 Kendall Rae Walkway. Old Bridge Sign. CC Gas Station. Enterprise sign is down but not black post.
